Contacting Your Representatives

Any rollback of these protections would have severe, lasting consequences for people like me, particularly for the Little People of America (LPA) community.

Some of the key areas where rollbacks to Section 504 would have a detrimental impact are:

1. **Access to Education:** Section 504 mandates that schools provide reasonable accommodations for students with disabilities, such as assistive devices and accessible learning environments. A rollback would mean that schools may no longer be required to meet these needs, leaving students with disabilities at risk of being excluded or left behind.
2. **Employment Equality:** Section 504 ensures that individuals with disabilities have equal access to employment opportunities and are protected from discrimination in the workplace. Any rollback would weaken protections for workers with disabilities, making it more difficult for people to find and retain employment, particularly for those of us with visible disabilities.


